- Accounts Receivable is \$355,439.79.
- Current Account Receivable as of March 3, 2022 is \$314,402.48
- Bank account is considered healthy
- Budgets are due April 5, 2022 for 2023
- Auditors asked for an extension which was granted until April 30, 2002
