 - o Year-To-Date Revenues exceed Expenses by \$348,227.53 on May 31, 2022.
- Prior to OPEB accrued costs and Depreciation costs, Revenues exceed Expenses by \$476,375.03 on May 31, 2022.
- Accounts Receivable Current
 - Accounts Receivable \$173,203.48 as of 5/31/22
 - O CURRENT Accounts Receivable \$861,386.31 as of 6/25/22
- Cash Balance
 - o The bank account is considered healthy as of May 31, 2022.
- This is the final year of MOVHD's three-year single audit contract with Perry & Associates. MOVHD would like to begin the bidding process for the next three-year contract.
- The following grants had monies returned to the Bureau of Public Health for Fiscal Year 2020:
 - Quick Response Team ODTA \$37,867.25
 - Epidemiology (EPI) \$4,888.11
 - Threat Preparedness \$39,820.59
- As of June 2022, the WIC grant for fiscal year 2022 is finalized. The first two quarterly invoices
 were submitted for payment in June 2022. MOVHD is currently in the process of working on the
 budget for the fiscal year 2023 WIC grant.

• May need to transfer money (400,000) out of our investment funds into our checking account until the WIC invoices are paid, at which time the money that was transferred from investments will be replaced.
