Finance Report: Alex Klosek, Finance Director presents the following as of May 31, 2022

- Year End FY2022
  - o Year-To-Date Revenues exceed Expenses by \$269,575.59 on June 30, 2022.
  - o Prior to OPEB accrued costs and Depreciation costs, Revenues exceed Expenses by \$411,620.21 on June 30, 2022.
- Accounts Receivable Current
  - o Accounts Receivable \$909,357.07 as of June 30, 2022. The reason for the amount is our WIC grants paid out later than usual.
  - o Current Accounts Receivable \$560,962.42 as of August 25, 2022
- Current Cash Balance
  - o The bank account is considered healthy as of June 30, 2022 and July 31, 2022.
- July 31, 2022 Financials
  - o Year-To-Date Revenues exceed Expenses by \$81,758.09 on July 31, 2022.
  - o Prior to OPEB accrued costs and Depreciation costs, Revenues exceed Expenses by \$94,912.04 on July 31, 2022.
  - o Accounts Receivable \$1,193,619.02 as of July 30, 2022. The reason for the amount is our WIC grants paid out later than usual.
  - o Current Accounts Receivable \$560,962.42 as of August 25, 2022. The reason for this amount is due to our WIC invoices and State Aid being paid.
- Covid Vaccine Grant
  - o In mid-2021, the state said to pull all vaccine costs out of the RRT Grant and place them in the Vaccine Grant. The grant ended on June 30, 2022, at which time we still did not have the grant.
    - The grant was finalized in September. All expenditure reports are done, and invoices submitted for \$235,000.00 as reflected in the financials for June 30, 2022
- WIC Budget was submitted online a few days ahead of the deadline. All invoices from WIC have been paid for FY 2022.

- We have received the GASB 68 and 75 reports from Perry and Associates. We can now move forward with our single audit.
- Covid Expansion Grant
  - o Still in process with the State
